**RE: LICENSEES AFFECTED BY HURRICANES KATRINA AND RITA**

The recent hurricanes which have ravaged the Gulf Coast have affected many out-of-state licensees of the Department. The Department is well aware that the hurricanes have disrupted the businesses and the lives of many of our licensees, destroying records and uprooting licensees. The Department has already received inquiries from some licensees asking if any accommodations can be made regarding license renewals.

The Department is sympathetic to the problems facing these licensees. We invite any licensee affected by these storms to contact the Department. Within the bounds of the Department's discretion, we will attempt to accommodate and address special needs on a case-by-case basis.
