
IT IS on this 10 day of July 2015;

ORDERED that Plaintiff's Motion for Sumamry Judgment is hereby GRANTED in favor of Plaintiff, Commissioner, against Defendant Da'Lynn White; and

IT IS FURTHER ORDERED that judgment be and is hereby entered in the amount of \$67,992.00 against Defendant Da'Lynn White and in favor of Plaintiff, Commissioner. This amount consists of: \$60,000.00 total in civil penalties for fifteen (15) violations of the New Jersey Insurance Fraud Prevention Act, N.J.S.A. 17:33A-1 et seq.; attorneys' fees of \$6,992.00 pursuant to N.J.S.A. 17:33A-5b; and a statutory fraud surcharge of \$1,000.00 pursuant to N.J.S.A. 17:33A-5.1.
