

This amount consists of: \$15,000.00 in civil penalties for three violations of the New Jersey Insurance Fraud Prevention Act, N.J.S.A. 17:33A-1 et seq.; attorneys' fees of \$2,871.00, pursuant to N.J.S.A. 17:33A-5b; cost of service of process in the amount of \$129.95, pursuant to N.J.S.A. 17:33A-5b; and \$1,000.00 constituting the statutory insurance fraud surcharge, pursuant to N.J.S.A. 17:33A-5.1. Defendant's driving privileges are suspended for a period of 1 year from the date of this order, pursuant to N.J.S.A. 39:6A-15.

IT IS FURTHER ORDERED that a copy of this Order be served upon all parties within 10 days of the date hereof.
