ORDERED that Plaintiff-Intervenor's Motion for Summary Judgment is GRANTED in favor of the Plaintiff-Intervenor as to Count Sixteen of its Complaint against Defendants David Walker, Esq. and Alexandra Gallegos Gonzalez; and

IT IS FURTHER ORDERED that judgment be entered in <sup>an</sup>the amount <sup>to be determined &</sup> of ~~\$1,033,722.00~~ jointly and severally against Defendants David Walker, Esq., and Alexandra Gallegos Gonzalez and in favor of the Plaintiff, Commissioner of the New Jersey Department of Banking and Insurance. ~~This amount consists of: \$1,000,000.00, jointly and severally in civil penalties for seven hundred fifty three (753) violations of the New Jersey Insurance Fraud Prevention Act, N.J.S.A. 17:33A-1 et seq.; attorneys' fees of \$31,722.00, jointly and severally pursuant to N.J.S.A. 17:33A-5b; and a statutory fraud surcharge of \$1,000.00 each, pursuant to N.J.S.A. 17:33A-5.1; and~~

IT IS FURTHER ORDERED, that pursuant to N.J.S.A. 39:6A-15, Defendants David Walker, Esq. and Alexandra Gallegos Gonzalez's driving privileges will be suspended for a period of one (1) year from the date of this judgment; and
