The Defendant, Kevin Lickfield, having been duly served with a copy of the Summons and Complaint in the above-entitled action and having been defaulted for failure to appear, answer or otherwise defend;

FINAL JUDGMENT is on this 15 day of September 2017,

entered in the amount of \$536,275.53 against Defendant Kevin Lickfield, and in favor of the Plaintiff, Commissioner of the State of New Jersey Department of Banking & Insurance. This amount consists of: \$525,000.00 in civil penalties for thirty-eight (38) violations of the Insurance Fraud Prevention Act, N.J.S.A. 17:33A-1 et seq.; attorneys' fees of \$7,657.00 pursuant to N.J.S.A. 17:33A-5b; costs of service of process in the amount of \$59.99 pursuant to N.J.S.A. 17:33A-5(b); \$1,000.00 constituting the surcharge pursuant to N.J.S.A. 17:33A-5.1.

IT IS FURTHER ORDERED that pursuant to N.J.S.A. 17:33A-26, judgment is entered in the amount of \$1,822.54 against Defendant, Kevin Lickfield, and in favor of Aetna. This amount consists of restitution pursuant to N.J.S.A. 17:33A-26 and prejudgment interest pursuant to R. 4:42-11.

IT IS FURTHER ORDERED that pursuant to N.J.S.A. 17:33A-26, judgment is entered in the amount of \$736.02 against Defendant, Kevin Lickfield, and in favor of Horizon. This amount consists of restitution pursuant to N.J.S.A. 17:33A-26 and prejudgment interest pursuant to R. 4:42-11.

IT IS FURTHER ORDERED that a copy of this Order be served upon all parties within 7 days of the date hereof.
