ORDER FOR SUMMARY JUDGMENT

This matter coming before the Court on the application of Gurbir S. Grewal, Attorney General of New Jersey, by Richard E. Wegryn, Jr., Deputy Attorney General, attorney for the Plaintiff, Commissioner, New Jersey Department of Banking and Insurance, for an Order of Summary Judgment against the Defendant, Fernando Madrigal, and the Court having considered the papers submitted by counsel, and for good cause shown;

It is on this 4 day of June, 2018;

ORDERED that Summary Judgment be and is hereby **GRANTED** in favor of plaintiff, Commissioner, New Jersey Department of Banking and Insurance, against Defendant, Fernando Madrigal; and

IT IS FURTHER ORDERED that Defendant, Fernando Madrigal, is adjudged liable for one violation of N.J.S.A. 17:33A-1 et seq., the New Jersey Insurance Fraud Act; and

IT IS FURTHER ORDERED that judgment be and is hereby entered against Defendant, Fernando Madrigal, in the amount of \$10,425.00 which consists of a civil penalty in the amount of \$5,000.00 pursuant to N.J.S.A. 17:33A-5b; attorney's fees in the amount of \$4,425.00 pursuant to N.J.S.A. 17:33A-5b; and a \$1,000.00 surcharge pursuant to N.J.S.A. 17:33A-5.1.; and

IT IS FURTHER ORDERED the driving privileges of Defendant, Fernando Madrigal, will be suspended in the State of New Jersey for one year effective the date hereof pursuant to N.J.S.A. 39A-15.
