This Court now finds that Defendant violated the New Jersey Insurance Fraud Prevention Act, N.J.S.A. 17:33A-1 to -30 ("Fraud Act"), by knowingly submitting, conspiring to submit, or knowingly benefitting from the submission of material false and misleading statements to Government Employees Insurance Company ("GEICO") on behalf of customers for the purpose of obtaining an automobile insurance policy, including but not limited to, false and misleading information concerning employement, education, driving history or marital status, in violation of N.J.S.A. 17:33A-4(a)(4)(b), -4(a)(5), and -4(a)(c);

FINAL JUDGMENT is on this 7 day of ∞ . 2024, entered in the amount of \$166,000.00 against Defendant John Sweeney, Jr., and in favor of the Plaintiff, Justin Zimmerman, Acting Commissioner of the New Jersey Department of Banking and Insurance.
