**ORDER OF FINAL JUDGMENT
BY DEFAULT**

THIS MATTER HAVING BEEN opened to the Court on the application of Matthew J. Platkin, Acting Attorney General of New Jersey, (by Chandra M. Arkema, Deputy Attorney General, appearing), attorney for Plaintiff, Marlene Caride, Commissioner of the New Jersey Department of Banking and Insurance on a motion for final judgment by default; and

Defendants, Sylvester Meyers and Simone Jackson (collectively, "Defendants"), having been duly served with copies of the Summons and

Complaint in the above-captioned action, and default having been entered for Defendants' failure to appear, answer, or otherwise defend;

This Court now finds that, by falsely representing to Progressive Garden State Insurance Company ("Progressive") on an automobile application that he was the only driver of the Enclave, and concealing the use of the Enclave by Defendant, Simone Jackson, Defendant Sylvester Meyers, violated N.J.S.A. 17:33A-4(a)(4)(b) and N.J.S.A. 17:33A-4(a)(3); and

This Court also finds that Defendant, Simone Jackson, knowingly benefitted from the insurance policy issued based upon the misrepresentations of Defendant, Sylvester Meyers, which is a violation of N.J.S.A. 17:33A-4(c); and

FINAL JUDGMENT is on this 5th day of August 2022, as follows:

1. \$5,000.00 against Sylvester Meyers, individually, for the Fraud Act violations alleged in Count 1 of the Complaint, pursuant to N.J.S.A. 17:33A-5(b);
2. \$5,000.00 against Simone Jackson, individually, for the Fraud Act violations alleged in Count 3 of the Complaint, pursuant to N.J.S.A. 17:33A-5(b);
3. A \$1,000.00 Fraud Act surcharge against Sylvester Meyers, individually, pursuant to N.J.S.A. 17:33A-5.1;
4. A \$1,000.00 Fraud Act surcharge against Sione Jackson, individually, pursuant to N.J.S.A. 17:33A-5.1;
5. Attorneys' fees in the amount of \$3,500.00 against Defendants, jointly and severally, pursuant to N.J.S.A. 17:33A-5(b);
6. Cost of service in the amount of \$68.00 against Simone Jackson, individually, pursuant to N.J.S.A. 17:33A-5(b);

IT IS FURTHER ORDERED, that a copy of this Order be served upon all parties within 7 days of the date of receipt.
