THIS MATTER HAVING BEEN opened to the Court on the application of Matthew J. Platkin, Attorney General of New Jersey, (by Sean Healy, Deputy Attorney General, appearing), attorney for Plaintiff, Justin Zimmerman, Acting Commissioner of the New Jersey Department of Banking and Insurance on a motion for final judgment by default; and

The Defendant, Atiyah Dixon (“Defendant”), having been duly served with a copy of the Summons and Complaint in the above-entitled action and having been defaulted for failure to appear, answer or otherwise defend;

This Court now finds that Defendant violated the New Jersey Insurance Fraud Prevention Act, N.J.S.A. 17:33A-1 to -30 (“Fraud Act”), specifically N.J.S.A.17:33A-4(a)(4)(b), and -4(a)(5), by making a false statement of no loss to Progressive Group of Insurance Companies (“Progressive”) on or about March 26, 2023, in support of an application to reinstate her automobile insurance policy in order to make a claim for damages from the reinstated policy during the period in which it had lapsed;

FINAL JUDGMENT is on this 22nd day of November 2024, entered in the amount of \$8,575 against Defendant Atiyah Dixon, and in favor of the Plaintiff, Justin Zimmerman, Acting Commissioner of the New Jersey Department of Banking and Insurance. This amount consists of \$5,000 in civil penalties for one violation pursuant to N.J.S.A. 17:33A-5(b); attorneys’ fees of \$2,500 pursuant to N.J.S.A. 17:33A-5(b); a statutory fraud surcharge of \$1,000.00 pursuant to N.J.S.A. 17:33A-5.1.; and costs of service in the amount of \$75 pursuant to N.J.S.A. 17:33A-5(b); and

IT IS FURTHER ORDERED that a copy of this Order be served upon all parties within 10 days of the date of receipt.
