
**ORDER OF ENTRY OF JUDGMENT

ORDERED that judgment shall be and hereby is entered in the amount of \$6,975.00 against Defendant, Frank F. Peralta Gil, and in favor of Plaintiff, Justin Zimmerman, Commissioner of the New Jersey Department of Banking and Insurance. This amount consists of \$3,500.00 in civil penalties for one violation of the Fraud Act, pursuant to N.J.S.A. 17:33A-5(b); attorneys' fees of \$3,300.00 pursuant to N.J.S.A. 17:33A-5(b); and a statutory fraud surcharge of \$175.00, pursuant to N.J.S.A. 17:33A-5.1; and
