WHEREAS RESPONDENT (Robert J Frye), a licensed Real Estate Broker licensed by the State of New Jersey, is subject to the provisions of the Real Estate Brokers and Salesperson's Act, N.J.S.A. 45:15-1 et seq.; and

WHEREAS at all times relevant hereto, Robert Frye was and continues to be the Broker of Record of Paparone Management Company Inc., 2016-A Briggs Road, Mt. Laurel, NJ 08054; and

WHEREAS the Real Estate Commission has secured evidence which indicates that RESPONDENT has violated certain provisions of the laws and regulations governing the conduct of New Jersey real estate brokers and salespersons as referenced above; and

WHEREAS the Commission and RESPONDENT have agreed to settle this matter in lieu of any further administrative action; and

WHEREAS RESPONDENT acknowledges that he has been made aware of his right to a full and formal hearing on any violations which the Commission may allege he has committed and his right to have the advice of counsel on the matters to which this Consent Order pertains, he is knowingly and voluntarily waiving the right to a hearing and counsel; and

WHEREAS, respondent Frye admits that he acted in violation of N.J.A.C. 11:5-4.1(a), 11:5-4.1(d), (e) and (f); by failing to pay commissions earned by a salesperson in his employ on eight (8) separate transactions, and by his failure to provide the required notifications to a salesperson when said commissions were withheld; and

IT IS THEREFORE AGREED TO BY THE PARTIES AND SO ORDERED that  
RESPONDENT agrees to pay a fine in the amount of \$1500.00; and it is further ordered  
and agreed that

RESPONDENT shall pay the fine within 30 days of the date of acceptance of this Consent  
Order. The fine shall be payable by certified check, cashier's check or money order payable to  
the "State of New Jersey" and sent to:

And it appearing that this matter can be resolved upon the consent of the parties, without  
resort to any other further administrative proceeding;

It is on this 19th day of December, 2014

ORDERED and AGREED that the terms of this Consent Order are approved by the  
Commission at a regular meeting on December 16, 2014; and;

It is further ORDERED AND AGREED that the Commission reserves the right to take  
further administrative action if the terms of this Consent Order are not fully complied with or if it  
obtains any other information that the respondent may have violated the Real Estate Brokers and  
Salesperson's Act, N.J.S.A. 45:15-1 et seq. or corresponding regulations, N.J.A.C.11:5-1.1 et  
seq.;
