WHEREAS the Commission and Respondent Sofroney have agreed to settle this matter in lieu of any further administrative action; and

WHEREAS, Respondent Sofroney admits that he acted in violation of N.J.S.A. 45:15-15-1 and 3, unlicensed activity, and N.J.S.A. 45:15-17(e) incompetency, by failing to promptly renew the real estate license of The Landis Co., LLC and the salespersons employed by The Landis Co., LLC in a timely manner for the 2013-2015 license term which resulted in an unlicensed period between July 1, 2013-September 9, 2013 when reinstatement was processed; and

WHEREAS Respondent Sofroney acknowledges that he has been made aware of his right to a full and formal hearing on any violations which the Commission may allege he has committed and

his right to have the advice of counsel on the matters to which this Consent Order pertains, he is knowingly and voluntarily waiving the right to a hearing and counsel; and

IT IS THEREFORE AGREED TO BY THE PARTIES AND SO ORDERED that

Respondent Sofroney agrees to pay a fine in the amount of \$10,000.00; and it is further ordered and agreed that

Respondent Sofroney shall pay the fine within 30 days of the date of acceptance of this Consent Order. The fine shall be payable by certified check, cashier's check or money order payable to the "State of New Jersey" and sent to:
