Respondent Adcock agrees to pay a fine in the amount of \$1,500.00; and it is further ordered and agreed that

Respondent Adcock shall pay the fine within 30 days of the date of acceptance of this Consent Order. The fine shall be payable by certified check, cashier's check or money order payable to the "State of New Jersey" and sent to:

And it appearing that this matter can be resolved upon the consent of the parties, without resort to any other further administrative proceeding;
