Executive Orders Financial Reports

State agencies must specify in each notice which proposes a rule the last date on which they will accept public comment. Agencies must always accept public comment: for a minimum of 60 days following publication in the *Register* of a Notice of Proposed Rule Making, or a Notice of Emergency Adoption and Proposed Rule Making; and for 45 days after publication of a Notice of Revised Rule Making, or a Notice of Emergency Adoption and Revised Rule Making in the *Register*. When a public hearing is required by statute, the hearing cannot be held until 60 days after publication of the notice, and comments must be accepted for at least 5 days after the last required hearing. When the public comment period ends on a Saturday, Sunday or legal holiday, agencies must accept comment through the close of business on the next succeeding workday.

PUBLIC NOTICE

Delaware River Basin Commission Notice of Extension of Written Comment Period for Proposed Rulemaking

SUMMARY: The Commission is extending by thirty-one (31) days the comment period for its proposed rulemaking published on the Commission's website on October 28, 2021 and in the New York State Register on November 17, 2021. The comment period will run through February 28, 2022, rather than the previously noticed date of January 28, 2022.

DATES: Written comments will be accepted through 5 p.m. on February 28, 2022. The previously published hearing dates, method for submitting written comments, and other aspects of the public process are unchanged.

SUPPLEMENTARY INFORMATION: The proposed rule would amend the Commission's Comprehensive Plan and Water Code concerning importations of water into and exportations of water from the Delaware River Basin; amend the Commission's Special Regulations – High Volume Hydraulic Fracturing to prohibit the discharge of wastewater from high volume hydraulic fracturing and related activities to waters or land within the Delaware River Basin; and incorporate key elements of the latter proposed amendments into the Commission's Water Quality Regulations. A preamble explaining the basis and background for the rule, along with the rule text and details of the public process, were published in the November 17, 2021 issue of the New York State Register, and appeared or will appear during November and early December 2021 in the Federal Register, the Pennsylvania Bulletin, the New Jersey Register, and the Delaware Register of Regulations.
