

A RESOLUTION extending Docket No. D-69-210 CP Final (Revision 12) for the Limerick Generating Station (“LGS”) Water Supply Modification Demonstration Project and Wadesville Mine Pool (WMP) Withdrawal and Streamflow Augmentation Demonstration Project (“the current docket”) until December 31, 2013 or until the Delaware River Basin Commission (“DRBC” or “Commission”) approves a revised docket, whichever occurs first.

WHEREAS, the current docket, issued on October 27, 2004 to Exelon Generation Company, LLC (“Exelon”) and last extended (with amendments) by Resolution No. 2011-12 on December 8, 2011, established terms and conditions for a demonstration project designed to test the use of WMP water as an alternative to water pumped from the Delaware River as a source of flow augmentation and make-up water in the Schuylkill River to compensate for cooling water withdrawn from the Schuylkill by the LGS;

WHEREAS, the current docket initially was approved for a period of four years; and in a timely manner on September 17, 2007, Exelon filed its application seeking (a) long-term approval for LGS operations and surface water withdrawals based upon experience gained during the demonstration project; and (b) consolidation of the Commission’s LGS approvals into a single comprehensive docket;

WHEREAS, to provide more time for data collection and for DRBC to consolidate its 12 prior approvals into a single docket, the Commission extended the LGS docket annually between 2008 and 2011; each such extension was the subject of a public hearing, and DRBC conducted two public meetings each year throughout the multi-year demonstration to review and discuss the most recent data and the totality of the demonstration to date; and

WHEREAS, based upon the information and data assembled during the term of the current docket, the Commission developed draft docket No. D-1969-210 CP-13 (“draft docket”), which was published for comment on June 28, 2012; a public hearing on the draft docket was conducted on August 28, 2012 and written comments were accepted through October 27, 2012;

WHEREAS, the Commissioners and staff require additional time to complete their review of the many comments received on the draft docket before the Commission considers action thereon;

WHEREAS, the current docket will expire on December 31, 2012 if it is not extended by the Commission prior to that date; now therefore,

BE IT RESOLVED by the Commission that Docket No. D-69-210 CP Final (Revision 12) for the Limerick Generating Station Water Supply Modification Demonstration Project and Wadesville Mine Pool Withdrawal and Streamflow Augmentation Demonstration Project, as amended by Resolution No. 2011-12, is hereby extended until December 31, 2013 or until the Commission approves a revised docket, whichever occurs sooner.
