Water Management Advisory Committee Meeting Highlights

Thursday, June 16, 2022 10:00 a.m. – 12:00 p.m.

Call to Order

The DRBC Water Management Advisory Committee (WMAC) was called to order by Kathy Thaeder (Artesian Water), Committee Chair, and was held with remote attendance only using Zoom and its call-in capabilities. Administration

- <u>Administrative</u>:
 - Committee Liaison Michael Thompson (DRBC) gave explanations as to why the meeting format was changed from a Zoom meeting to a Zoom webinar. Committee members were elevated to a panelist position, while non-committee members remained as attendees with more restricted meeting access. It was communicated that at any time during the meeting, attendees may raise their hand or post in the meeting chat.
- <u>Roll Call</u>:
 - Roll call was performed by Committee Liaison Michael Thompson (DRBC).
- Public Participation:
 - Kathy Thaeder (Artesian Water) inquired if there were any members of the public wishing to make comments, or if there were items to raise which may warrant additional time for public comment at the end of the meeting. No comments or items were offered.
- <u>Highlights</u>:
 - The highlights of the February 17, 2022, meeting were approved and will be posted on the WMAC webpage. A motion for approval was made by Kelly Anderson (PWD) and seconded by Preston Luitweiler (WRA-DRB). There was no discussion and there were no abstentions; the motion passed unanimously.

- <u>Membership</u>:
 - Kathy Thaeder (Artesian Water) reported the WMAC positions for the Agriculture constituency and the League of Women Voters/Civic Organization constituency expiring on 6/30/2022 were filled by Sandra Howland (New Jersey Department of Agriculture) and Kathy Cook (League of Women Voters of Pennsylvania), respectively. Additionally, Seung Ah Byun (CCWRA) has replaced Janet Bowers (CCWRA) as the representative.
 - Michael Thompson (DRBC) reported that the current Chair & Vice Chair elections expire 6/30/2022. Per the WMAC rules of Practices and Procedures, the current Vice Chair (Seung Ah Byun, CCWRA) becomes the new Chair starting July 1, 2022. Michael Thompson (DRBC) opened the floor for nominations. Preston Luitweiler (WRA-DRB) nominated Kelly Anderson (PWD) who accepted the nomination; there were no more nominations, and Michael Thompson (DRBC)

closed the floor for nominations. Brenan Terrier (NYDEC) motioned to appoint Kelly Anderson (PWD) as the WMAC vice-chair beginning July 1, 2022. Preston Luitweiler (WRA-DRB) seconded the motion. There was no discussion and were no abstentions; the motion passed unanimously.

Presentations

Population Served

Chad Pindar (DRBC) provided a summary of previous efforts to estimate a population which is served by water withdrawn from the Delaware River Basin, which was performed in 2018 based on population data from 2016. The recently approved FY2023-2025 Water Resources Program includes a task to update the Population Served estimate for the Delaware River Basin. The general proposed methodology was outlined. DRBC Storage Study Update

Chad Pindar (DRBC) provided an update on the Storage Study currently being performed by Mott McDonald, in cooperation with the DRBC. Of note, the contract length was extended to December 31, 2022. The current project activities include overcoming significant delays obtaining technical information on some sites, finalizing evaluation criteria, and completing Storage Project Summaries (SPS) for about 40 projects (including associated scoring sheets). Estimated Groundwater Availability in the Delaware River Basin

Sara Sayed (DRBC) gave a presentation on a project currently underway by the DRBC Water Resource Planning Section which assesses groundwater withdrawals in the Delaware River Basin on the basis of calculated availability. This presentation is largely an update to a similar presentation given at the February 17, 2022 WMAC meeting. Evaluating low flow patterns, drivers and trends in the Delaware River Basin and Chesapeake Bay Watershed

Brandon Fleming, (Groundwater Specialist at the USGS Pennsylvania Water Science Center) gave a presentation covering two recent publications related to low-flow streamflow patterns, drivers and trends. The publications are:

One question was asked about the definitions of a "flash drought", to which Mr. Fleming responded that "flash drought is rapid onset and often very localized drying conditions. The designation of this can be subjective and vary in different regions."
