### **Contest Deadline and General Instructions:**

Entries returned via internet must be received no later than 11:59 pm Eastern Standard Time, September 23, 2011. Mail-in entries must be postmarked no later than September 23, 2011. Entries must be typed. No handwritten entries will be accepted. Official Entry Form must be used for contest submission. Class entries are acceptable if submitted in the name of the subject teacher. Entries are limited to one per person or class.

#### Winner Selection:

Winners will be selected from all eligible entries received. Winners will be notified by telephone or email on or about September 30, 2011.

### <u>Eligibility:</u>

Contest is open to all New Jersey public, non-public and charter high schools, teachers and students. Commissioners and employees of NJIIAHC, their families, and household members are not eligible to win.

### General:

Void where prohibited by law. Subject to all federal, state and local laws and regulations. Prize cannot be transferred, exchanged, refunded or sold. All expenses after receipt and use of the prize and any federal, state and local taxes on the prize are the sole responsibility of the prizewinner.

### Prizes/Award Recognition:

- School with First Place Winner: Computer (One winner). Estimated Value: \$800. A Gubernatorial Proclamation and/or Legislative Resolution will be presented in recognition of the school and first place winner.
