#### **School Performance Report Update**

Ms. Jessica Merville, Director Division of Educational Services Office of Performance Management

School Performance Reports for the 2021-2022 school year were released on April 5, 2023. The reports included all data available prior to the pandemic, except for median student growth percentiles (mSGPs). The NJDOE expects to resume reporting on mSGPs in the 2022-2023 reports. The 2021-2022 reports link to the alternate growth measure (RSIM) used for 2021-2022 accountability. While some data are comparable to pre-pandemic performance, other data elements continue to be impacted. The NJDOE recommends caution in comparing data from 2019-2020 to 2021-2022 across years. ## Office of Assessment

With the successful reinstatement of the NJSLA in the Spring of 2022, the New Jersey Department of Education (NJDOE) discontinued the Start Strong Assessments effective Fall 2023. NJDOE is grateful to the education community for their partnership in successfully implementing the Start Strong assessment over this period. The official notification was sent out on March 22, 2023 by NJDOE Broadcast which may be viewed at Discontinuation of Start Strong Assessments

Mr. Boczany introduced the National Assessment of Educational Progress (NAEP) which began in 1969 and administered by the National Center for Education Statistics (NCES). He further mentioned that schools and students are randomly selected. Please note, Title I schools MUST participate per National
