Bickram Singh, "Providing funds to parents without accountability requirements."

- Vincent DeLuca, "Parent Academies to share the information with all parents and community members."
- Phyllis Lewis, "When students com to Detention Center we find out they are Homeless, and the school district do not know."
- Vincent DeLucia, "Collaborating with local municipalities, social services, local faith groups."
- Diahann DeRuggiero, "Unaccompanied Youth who are ESL eligible do not always advise the McKinny-Vento school liaison of needing assistance. This happens often.

**Question 2:** How could braided funding support collaboration between agencies while ensuring the availability of support for students experiencing homelessness?

**Answer:** NJGPA Spring Assessment: Are current seniors (included in the 2024 Cohort) who failed to sit for the Spring 2022 or the Fall 2022. A student must participate and attempt the NJGPA in order to unlock use of the second or third pathway to graduation. So, yes, a student who is intending to graduate this school year mut have participated in the NJGPA.
