Following the return to public session, Chairperson Bender acknowledged the attendance of the Complainant (James Smith), the Respondent (Emmanuel Capers), along with John Whipple, Respondent's counsel, in connection with the matter docketed as C48-18. Chairperson Bender, Commission member Collins and DAG Frey advised the parties as follows: the record was closed; because the record was closed, the Commission would neither be taking nor receiving testimony from either Complainant and/or Respondent; the Commission would not consider any comment(s) made by Complainant or Respondent and/or any document(s) submitted by Complainant or Respondent in its review of the above-captioned matter unless the comment(s) or document(s) was already memorialized in the record; and the Commission compelled Respondent's attendance so that he could avail himself, as Complainant did, of the opportunity to offer public statements about the above-captioned matter. Following these advisements, Respondent (through counsel) was offered the opportunity to provide public comments/statements.

10:32 a.m. In his remarks, Respondent (through counsel) expressed that the ALJ conducted a "fair and balanced" trial. Respondent noted that the ALJ issued a "well-reasoned, clear and concise opinion," after a review of the documents and observance of testimony. Respondent explained that the ALJ's opinion was "one hundred percent on the mark," her findings of fact were "one hundred percent accurate," and the legal analysis was "careful and concise" and Respondent agrees with the ALJ's decision "on all respects."

At the conclusion of Respondent's public comments/testimony, Complainant was offered the opportunity to provide public comments/statements.

10:38 a.m. Complainant disagreed with the ALJ's analysis and reiterated that "accepting an invitation to stay at a luxury resort opens up a Pandora's box." Complainant further reiterated the allegations in his Complaint, including that the Superintendent and the Board President "ordered" him to conduct the investigation; and he conducted the investigation as requested. Complainant concluded by noting that Respondent "had the District drive him down to Trenton," and Complainant had to drive himself to Trenton.
