School Ethics Commission Meeting Public Session Minutes

April 27, 2021

Chairperson Robert Bender called the meeting of the School Ethics Commission (Commission or SEC) to order at 9:33 a.m.

Notice of the meeting was provided to the State House Press Corps and the Secretary of State and filed as required by the Open Public Meetings Act.

Also in attendance were Kathryn Whalen, Director, Offices of School Ethics and Compliance, Jeannine Pizzigoni, staff member, and Jaclyn Frey, Deputy Attorney General (DAG). Everyone in attendance at the meeting participated via telephone/video due to the ongoing COVID-19 pandemic.

II. First Public Comment

At the start of the meeting, Director Whalen explained to the public (who also accessed the meeting by telephone due to the ongoing COVID-19 pandemic) how the meeting would be conducted. More specifically, it was explained that the public would be afforded the opportunity to provide public comment regarding his/her case; the Commission would then adjourn to executive session (on a different conference line); the Commission would return to public at approximately 12:00 p.m.; at that time, members of the public would be afforded another opportunity to provide public comment in connection with his/her case; and then the Commission would vote on matters pertinent to its business.

9:35 a.m. Sarah Aziz, the named Complainant in the matter docketed as C03-21, noted her attendance, and read the following statement:

My name is Sarah Aziz. I'm from Monroe Township. I think it's important to note that most people who file ethics complaints against board members are neither attorneys nor are they represented by attorneys and yet board members can hire professional attorneys, paid for by school boards, to defend themselves in these cases. I hope the School Ethics Commission takes steps to make sure that board members are not using school boardfunded attorneys to intimidate complainants by threatening them with civil action when these complainants are acting well within their legal rights. I hope the Ethics Commission takes steps to protect complainants from retaliation. Furthermore, if during the course of their investigation of violations of the School Ethics Act, the [E]thics [C]ommission

becomes aware of possible illegal acts that are outside its purview, I hope they take it upon themselves to report these possible violations to the relevant agencies.

- Tyrone Tarver, former member of the Orange School District Board of Education (Board), former 2020 Board President, supporter of Complainant in the matter docketed as C01-21, noted his attendance and stated that he is neither a Complainant nor a Respondent in this matter; however, he is present to support the Complainant in this matter. He further stated he would like to urge the Commission to deny Respondent's Motion to Dismiss. Mr. Tarver provided a certification for the Complainant, which included the facts surrounding this matter that were "laid out pretty well" and that were also supported by District policy and "precedent that it happened at our previous school board meetings." Mr. Tarver noted that Respondents did not include any "material" or note any Board policies to support their claims. Mr. Tarver further noted the only evidence that Respondents submitted was an email from Mr. Tarver, which Respondents "purposefully on purpose misinterpreted to support their decisions." Therefore, Mr. Tarver requests that the Commission "move forward with the action that was carried out in the Complaint." Mr. Tarver stated that an Open Public Records Act (OPRA) request was filed with the Board, but the OPRA request was denied "until the school board could vote and have a second vote to approve the redactions, and that's 100% against State law." According to Mr. Tarver, the District has to provide documents that are requested, and although the law allows you redactions, the Board does not "have any ground sustainable and concerning or denying the Complaint." Mr. Tarver added the denials were not based "on any legal advice." Finally, Mr. Tarver stated he reviewed the Board's meeting minutes and he noticed that the Board did not "conduct any vote to approve these minutes"; however, Complainant requested a copy of the meeting minutes to support her Complaint, which "should pretty much spell out the whole situation in support of her whole Complaint.
- **9:39 a.m.** Christopher Treston, the named Respondent in the matter docketed as C71-18, noted his attendance, thanked the Commission for "the opportunity," and stated he was only here "to observe."
- **9:39 a.m.** Adi Nikitinsky, the named Respondent in the matter docketed as C03-21, noted his attendance, but did not offer any public comments/statements.
- **9:39 a.m.** Heather Garcia, the named Complainant in the matter docketed as C56-20, noted her attendance, thanked the Commission for its time, but did not offer any public comments/statements.
- **9:40 a.m.** Liz Preuster, a member of the public, noted her attendance, but did not offer any public comment/statement.
- **9:40 a.m.** Christine Skurbe, member of the Monroe Township Board of Education and interested party in the matter docketed as C03-21. Ms. Skurbe noted her attendance and stated, "within the Complaint my campaign was brought in and we were wrongly accused of violating campaign election laws and I wanted it duly noted that there is absolutely nothing that our campaign has done to violate any laws. We have filed all the paperwork and the accusation in there is completely false and there's no evidence to support it, so I just wanted that duly noted to the Commission. Thank you."

Now therefore be it further resolved that the Commission will return to open session to conduct business at the conclusion of Executive Session.
