# School Ethics Commission Meeting Public Session Minutes

# **August 23, 2022**

Chairperson Robert Bender called the regularly scheduled meeting of the School Ethics Commission (Commission or SEC) to order at 9:36 a.m.

Notice of the regularly scheduled meeting was provided to the State House Press Corps and the Secretary of State, and filed as required by the Open Public Meetings Act.

## II. First Public Comment

At the start of the meeting, Chairperson Bender explained to the public (who also accessed the meeting by telephone/video) how the meeting would be conducted. More specifically, Chairperson Bender explained that the public would be afforded the opportunity to provide public comment regarding his/her case; the Commission would then adjourn to executive session (on a different conference line); the Commission would return to public at approximately 12:00 p.m.; at that time, members of the public would be afforded another opportunity to provide public comment in connection with his/her case; and then the Commission would vote on matters pertinent to its business.

Director Whalen also advised the public as follows: individuals wishing to provide public comments/statements during First and Second Public Comment must be speaking about matters on the Commission's agenda; anyone wishing to provide public comments/statements about a matter not on the agenda should reserve their public comments/statements for New Business; anyone offering public comments/statements about a matter on the agenda is asked not to relitigate the merits of their case as the Commission's review of matters is limited to the written submissions; and everyone in attendance is asked to exercise an appropriate degree of decorum as this is a public forum.

**9:39 a.m.** Sarah Aziz, Complainant in the matters docketed as C82-21 and C10-22, noted her attendance, but did not offer any public comments/statements.

**9:39 a.m.** Rachel Taylor, counsel on behalf of Respondent in the matter docketed as C32-22, noted her attendance, but did not offer any public comments/statements.

**9:39 a.m.** Brian Fabiano, Complainant in the matter docketed as C37-22, noted his attendance and offered a statement summarized as follows:

Good morning, I wanna offer the following comments quickly. I know that the Commission has a lot on their plate, and we do appreciate all you do. One of the most challenging things that citizens have is, is, you know, filing a complaint when we see wrondoings. In particular, to the Board of Education, in Monroe Township, where there's quite a bit going on and I'm sure the Commission can recognize that by the level of things that they have to review in front of them. One of the challenging things as a citizen is we're put up against (inaudible) attorneys that are hired by these boards of education, funded by our own tax dollars. So, while our complaints might not be always perfect, uh, the details we provided and that I provided in some of my concerns, uh, you know, are the best of our ability. I do believe that whether or not we have as individuals offered information to other pending cases should not preclude us from having our complaints reviewed by the Commission. And I highly respect the Commission and, and, the job that you are, you know, that you do to keep our elected officials honest and there will be something you'll review today in "Other Business" that I hope you do take into consideration that we are all our own person and although we are sometimes asked for information in other avenues, we all should have our right to have the Commission review any wrongdoings or evidence that we present that is against the Code of Ethics. I do appreciate all that you guys do and that's all I'd like to offer at this time.

### X. Second Public Comment

What happened at that point was I received a letter from the Ethics Commission notifying me that I would hear from the Deputy Attorney General that never occurred. That case was adjudicated before Judge Stokes. I've still yet to be able to find out what the outcome of that case was. The Deputy Attorney General is not answering me. The Commission is not answering me. I've had to OPRAH request the information, which I still have not received. So, for, for a process that I thought was fair and equitable in the very, very beginning, has now really become very unfair and unequitable. That's my only comment. Thank you, Tom. Whittles, Whittle versus Fahim Abedrabbo Case 23-21. Thank you.

**10:34 a.m.** Sarah Aziz, Complainant in the matters docketed as C82-21 and C10-22, again noted her attendance and offered a statement as follows:

I noticed on the agenda if there was a motion to put C55-22 in abeyance. I thought I heard that C10-22 would also be put in abeyance, so although it's not on the agenda to be

put in abeyance. So you know, I have some questions about, you know, abeyance, just like Mr. Fabiano. So I could also speak with you about that.

Director Whalen informed Ms. Aziz that she would address her concerns, as well as Mr. Fabiano's concerns at the end of the meeting.
