School Ethics Commission Special Meeting Public Session Minutes

February 27, 2024

Chairperson Bender called the special meeting of the School Ethics Commission (Commission or SEC) to order at 9:31 a.m.

Notice of the special meeting was provided to the State House Press Corps and the Secretary of State, and filed as required by the Open Public Meetings Act.

Also, in attendance were Brigid C. Martens, Director, Office of School Ethics, Jeannine Pizzigoni, staff member, and Amna Toor, Deputy Attorney General (DAG). Commissioners Michael Carucci and Dennis Roberts participated by telephone/video.

II. First Public Comment

At the start of the meeting, Chairperson Bender explained to the public how the meeting would be conducted. More specifically, Chairperson Bender explained that the public would be afforded the opportunity to provide public comment; the Commission would then adjourn to executive session; the Commission would return to public at approximately 12:00 p.m.; at that time, members of the public would be afforded another opportunity to provide public comment; and then the Commission would vote on matters pertinent to its business.

Director Martens also advised the public as follows: individuals wishing to provide public comments/statements during Public Comment regarding a matter pending before the Commission are asked not to litigate the merits of their case as the Commission's review of matters is limited to the written submissions; and everyone in attendance is asked to exercise an appropriate degree of decorum as this is a public forum.

9:34 a.m. Graceanne Talarico, Complainant in the matter docketed as C56-23, was present at the meeting and offered the following comment/statement:

My name is Graceanne Talarico and I am the Complainant for C56-23. I would just like to acknowledge and thank all the SEC members for all the hard work and time you put in to ensuring that the school board member code of ethics and prohibited conduct is followed. Thank you for providing advisory opinion guidance and structure for school board members to abide

by. What you do is very much appreciated and needed to create fairness and a respectful environment for all. Thank you.

9:34 a.m. Alix Hayes, Ocean Township community member and former member of the Ocean Township Board of Education, noted her attendance and offered the following public comment/statement:

Hi. My name is Alix Hayes. I wanted to thank the Commission and all the staff for the incredibly important work you do — I recognize that there has been a huge influx of cases, particularly over the last couple of years and seems you're working diligently to usher in some extra meetings and to get these cases heard as quickly as possible and I appreciate that.I also wanted to thank you for having the sessions in person ... as a former TV journalist and advocate for equity in education, transparency is incredibly important, as you know.

The Ocean Township School District submitted an Advisory Opinion earlier this year to which this body graciously rendered a ruling in A05-23, which essentially negated a previous advisory opinion about the ethical rules of a conflicted (school board) president and vice president appointing committee members and committee chairs — and also those conflicting folks (members) serving on committees to which they have conflicts of family members.

Our School Board has since refused to abide by your advisory opinion and in November (2023) voted, in a motion in open session, *not to follow advisory opinions rendered by the SEC*. This has been brought up since the new leadership in January, and our district and majority board members *still will not follow your advisory opinion*. This dilutes your authority, your expertise, and essentially best practices that school districts follow the SEC's advisory opinions as if they were case law. This seems to also be a sign of the times: to seek an opinion from a higher authority, and then, when you don't like that opinion, you simply ignore it. It's sad and in a perfect world the SEC's Advisory Opinions would be followed. Thank you.
