**WHEREAS**, the South Amboy Board of Education member, Barbara Rone, was found by the School Ethics Commission to have voted in favor of a resolution to hire special counsel to investigate the conduct of the South Amboy Superintendent of Schools with respect to a legal dispute in which she was an adversary of the superintendent; and

**WHEREAS**, the School Ethics Commission concluded that such conduct violated *N.J.S.A.* 18A:12-24(c) of the School Ethics Act; and

**WHEREAS**, after considering the facts determined during the course of the investigation and Barbara Rone's testimony regarding this matter, the School Ethics Commission, in a decision dated October 28, 1997, recommended to the Commissioner of Education that he impose upon Ms. Rone the penalty of censure pursuant to *N.J.S.A.* 18A:12-29(c) and *N.J.A.C.* 6:3-9.19(c)1; and

**WHEREAS**, comments with regard to this penalty were untimely filed before the Commissioner by Ms. Rone; and

**WHEREAS**, the Commissioner has concluded that the Commission's censure is the appropriate penalty for the aforementioned violation for the reasons set forth in the Commission's decision; now therefore

**BE IT RESOLVED**, that Barbara Rone is hereby censured as a school official found to have violated the School Ethics Act; and

**BE IT FURTHER RESOLVED**, that the South Amboy Board of Education is ordered to read this resolution at the next public meeting following its adoption by the School Ethics Commission and to post it in such places as the Board posts its public notices.
