## **Final Decision**

In the Matter of the Suspension of the Teaching Certificates of Jessica Macaluso, Board of Education of the Borough of Pompton Lakes, Passaic County.

### **Synopsis**

This matter was opened before the Commissioner of Education on May 20, 2020, by way of an Order to Show Cause served by the petitioner, the Board of Education of the Borough of Pompton Lakes (Board) upon the respondent, Jessica Macaluso, requiring respondent to show cause why an order should not be entered suspending her teaching certificates for unprofessional conduct pursuant to *N.J.S.A.* 18A:26-10 after she resigned her position without giving the sixty-day (60) notice required by her contract with the petitioner. Respondent was duly advised that – pursuant to *N.J.A.C.* 6A:3-1.5(e) – failure to respond would cause each allegation raised by the Board to be deemed admitted and might result in summary decision by the Commissioner. The respondent failed to answer the order, despite ample opportunity to do so.

There being no response to the order to show cause, the Commissioner concluded that the allegations, which respondent has chosen not to deny, may be deemed admitted and justify suspension of respondent's certificates. Accordingly, respondent's certificates were suspended for a period of one year from the date of the filing of this decision – a copy of which was forwarded to the State Board of Examiners for the purpose of effectuating this order.

#### **Final Decision**

In the Matter of the Suspension of the Teaching Certificates of Jessica Macaluso, Board of Education of the Borough of Pompton Lakes, Passaic County.

The record of this matter has been reviewed. The Pompton Lakes Board of Education filed a petition seeking the suspension of respondent Jessica Macaluso's teaching certificates pursuant to *N.J.S.A.* 18A:28-8 because she resigned without providing the Board with the requisite statutory notice. The Commissioner issued an Order to Show Cause on May 20, 2021, which the Board served on respondent on the same date. Respondent did not formally respond to the Order to Show Cause, despite being given multiple opportunities to do so. Accordingly, the Commissioner finds that the respondent's certificates should be suspended pursuant to *N.J.S.A.* 18A:28-8, and further finds that a one-year suspension of the respondent's certificates is the appropriate penalty.

Accordingly, the respondent's teaching certificates are suspended for a period of one year from the filing date of this decision, a copy of which shall be forwarded to the State Board of Examiners for implementation of the suspension.
