At its meeting of June 27, 2024, the New Jersey State Board of Examiners (Board) reviewed an affidavit that Joanna Maggio, Paralegal to Robert Gamburg, Esquire of the firm Gamburg & Benedetto, LLC, counsel for David Checchio, forwarded regarding Checchio. Checchio currently holds a Teacher of Elementary School (K-6) Certificate Of Eligibility; a Teacher Of Students With Disabilities Certificate Of Eligibility; a Teacher of Elementary School With Subject Matter Specialization: Social Studies In Grades 5-8 Certificate Of Eligibility; a Teacher of Elementary School With Subject Matter Specialization: Social Studies In Grades 5-8 Certificate Of Eligibility; a Teacher of Elementary School With Subject Matter Specialization: Social Studies In Grades 5-8 Certificate In Grades 5-8 Certificate Of Eligibility With Advance Standings; a standard Teacher of Elementary School Teacher (K-6) certificate; and a standard Teacher Of Students With Disabilities certificate.

Checchio agreed to relinquish his certificates with the force and effect of a revocation and all attendant consequences in his affidavit to that effect to the Board. At its meeting of June 27, 2024, the Board voted to accept Checchio's relinquishment with the force and effect of a revocation pursuant to *N.J.A.C.* 6A:9B-4.10.

Accordingly, on this 27th day of June 2024, David Checcio's Teacher of Elementary School (K-6) Certificate Of Eligibility; Teacher Of Students With Disabilities Certificate Of Eligibility; Teacher of Elementary School With Subject Matter Specialization: Social Studies In Grades 5-8 Certificate Of Eligibility; Teacher of Elementary School With Subject Matter Specialization: Social Studies In Grades 5-8 Certificate Of Eligibility With Advance Standings; standard Teacher of Elementary School Teacher (K-6) certificate; and standard Teacher Of Students With Disabilities certificate are hereby REVOKED, effective immediately. It is further ORDERED that Checcio return the above-mentioned paper certificates, if issued, to the Secretary of the State Board of Examiners, Office of Certification, P.O. Box 500, Trenton, NJ 08625-0500 within 30 days of the mailing date of the decision.
