SCOTT D. NALICK : ORDER ACCEPTING RELINQUISHMENT

At its meeting of September 19, 2025, the New Jersey State Board of Examiners (Board) reviewed an affidavit it received from Maggie Hemler, of Gelman Law, LLC, counsel for Scott D. Nalick, regarding Nalick. Nalick currently holds a Teacher of Elementary School in Grades K-6 Certificate Of Eligibility (CE), issued July 2011; a Teacher of Middle School with Subject -Matter Specialization: Social Studies in Grades 5-8 CE, issued in July 2011; a Teacher of Students with Disabilities CE, issued June 2012; a Teacher of Elementary School in Grades K-6 Standard certificate, issued August 2016; a Teacher of Middle School with Subject -Matter Specialization: Social Studies in Grades 5-8 Standard certificate, issued in August 2016; and a Teacher of Students with Disabilities Standard certificate, issued in August 2016.

Nalick agreed to relinquish his certificates with the force and effect of a revocation and all attendant consequences in his affidavit to that effect to the Board. At its meeting of September 19, 2025, the Board voted to accept Nalick's relinquishment with the force and effect of a revocation pursuant to *N.J.A.C. 6A:9B-4.10*.

Accordingly, on this 19th day of September 2025, it is therefore ORDERED that Scott D. Nalick's Teacher of Elementary School in Grades K-6 Certificate Of Eligibility (CE), Teacher of Middle School with Subject -Matter Specialization: Social Studies in Grades 5-8 CE, Teacher of Students with Disabilities CE, Teacher of Elementary School in Grades K-6 Standard certificate, Teacher of Middle School with Subject -Matter Specialization: Social Studies in Grades 5-8 Standard certificate, and Teacher of Students with Disabilities Standard certificate

are hereby ORDERED RELINQUISHED, with the force and effect of a revocation, effective immediately. It is further ORDERED that Nalick return the above-mentioned paper certificates, if issued, to the Secretary of the State Board of Examiners, Office of Certification and Induction, P.O. Box 500, Trenton, NJ 08625-0500 within 30 days of the mailing date of the decision.
