CONVENING

State Board of Education President Arcelio Aponte convened the public meeting at 10:00 a.m. with the reading of the statement pertaining to the public session of the State Board meeting as it complies with the New Jersey Open Public Meetings Act.

Announcements

Sign Language Interpreters

President Aponte introduced and welcomed the two the Sign Language Interpreters, Monica Ayrer and Rita Jo Scarcella.

Permanent Student Representative

Nora Faverzani is the 2018-2019 permanent student representative to the State Board of Education. Nora is a senior from Ocean City High School in Cape May County. Unfortunately, Nora was unable to attend today's meeting and present her report to the State Board members.

Commissioner Repollet commended Nora's participation in the Department's first Black History Month celebration that was held on February 21, 2019.

Public Testimony

President Aponte stated public testimony would not be held today. He also stated that public testimony will be held on April 17, 2019. Topics for the April public testimony session include the Career and Technical Education endorsement (Chapters 9 and 9B) and the Religious Holidays Calendar.

Registration for the April 17, 2019 public testimony session will open on Thursday, March 28, 2019, and will close at noon on Thursday, April 11, 2019.

President Aponte further stated that anyone interested in speaking at and/or also attending the public testimony session must register so the State Board staff can make proper arrangements for space. State Board Committee Reports

Special Education Committee—Mary Beth Berry, chair of the Special Education Committee stated that committee will be meeting after the Board meeting to discuss any updates to Special Education. Mrs. Berry also reported that she and Vice President Goldenberg attended the New Jersey Special Education Advisory Council meeting on February 14. The council provides guidance to stakeholders who work with special education services and address any issues that may arise within those services.

Career and Technical Education—Kathy Goldenberg, chair, reported on the CTE committee meeting that was held December 19 with Department staff. Committee members discussed Perkins V and its regulatory changes. Additionally, Vice President Goldenberg and Mary Beth Berry attended a school visit to Brooklyn

PTECH. During the visit Vice President Goldenberg and Mary Beth Berry witnessed the CTE collaboration that PTECH has with International Business Machines Corp. (IBM) and how through them the students experience working in a professional work environment.

Vice President Goldenberg stated the committee met again January 16 and further discussed Perkins V, CTE teacher certification and were introduced to some proposals that will be brought to the Board soon.

President Aponte stated that Committee reports will be provided at the April 17 State Board meeting.

COMMISSIONER'S REPORTS

Consent Order

Chris Huber, Special Assistant to the Commissioner, informed the Board Members that the Department has entered into a consent order with the Education Law Center to resolve the ongoing litigation concerning graduation assessment and associated regulations. Huber stated the consent order was signed by the appellate division and allows the Department to apply the class of 2019 graduation assessment requirements to the classes of 2019 and 2020. Mr. Huber further stated that those students will have three pathways to graduating: passing the decided graduation assessment (including Algebra I & ELA 10), passing an assessment from the menu of options (PSAT, SAT, ASVAB), or entering the portfolio appeals process. Mr. Huber stated that the Department staff intends to consult with the Board members to work on the Statewide assessments for the class of 2021 and beyond.

Graduation Data and Overview of Performance Reports

Dr. Linda Eno, Assistant Commissioner, Division of Academics and Performance and her staff presented the 2017-2018 school performance reports to the State Board Members. She stated that the performance reports have been enhanced based on community input to provide more informative and clear summary reports, improve navigation tools, put emphasis on student growth, and provide more information about CTE. She also stated that the reports will be released to the public this month.

New Jersey Student Learning Standards (NJSLS) Update

Dr. Linda Eno, Assistant Commissioner, Division of Academics and Performance and Dr. David Greer, Deputy Assistant Commissioner of Academics presented updates to the New Jersey Student Learning Standards to the State Board Members. They stated that their team will host regional information sessions in April for the Connected Action Roadmap (CAR) process and for the mathematics and ELA instructional teams. The Division of Academics and Performance has established teams for review of the following standards: comprehensive health and physical education, science, social studies, technology, visual and performing arts, world languages, and 21st century life and careers. Dr. Eno and Dr. Greer also stated that the review teams are also scheduled have a Spring 2019 kickoff at the College of New Jersey for all review team members.
