Convening

State Board of Education President Kathy Goldenberg convened the public meeting at 9:07 a.m. with the reading of the statement pertaining to the public session of the State Board meeting as it complies with the New Jersey Open Public Meetings Act.

President's Reports

Public Testimony

President Goldenberg stated that for the month of November, the State Board of Education will hear public testimony on Chapter 30, the Evaluation of the Performance of School Districts.

President Goldenberg stated that for the month of December, the State Board of Education will not hear public testimony as there are no educational topics for discussion.

Permanent Student Representative

President Goldenberg introduced the State Board of Education's permanent student representative, Miss Anna Paszkiewicz. Miss Paszkiewicz is a senior at Palmyra High School in Burlington County.

Miss Paszkiewicz stated that extracurricular activities are in full swing at schools across the State. She stated she created and distributed a school survey to student council advisors of New Jersey Association of Student Councils (NJASC)member schools to find out what new clubs, sports and extracurriculars were put into place in middle and high schools in New Jersey for the 2023-24 and 2024-25 school years. She further stated she was pleased to receive information about many new clubs and activities that are being offered throughout the State. She stated that extracurriculars are an

important way for students to become involved in their school community and interact with their peers outside the classroom.

*E. Resolution to Adopt Proficient Level Cut Scores for WIDA Alternate ACCESS for Multilingual Learners (MLs) Assessments (grades K-12)

• Approved the following resolution setting forth the adopted the proficiency level cut scores for ACCESS/Alternate ACCESS for ELLs assessments (grades K-12), pursuant to N.J.A.C. 6A:8-4.

Resolution to Establish Performance Level Cut Score Standards for the WIDA Alternate ACCESS

Whereas, the New Jersey State Board of Education (State Board) has required that all students identified as multilingual learners (MLs) and enrolled in a language instruction education program in kindergarten through grade 12 be assessed in English language proficiency in accordance with N.J.A.C. 6A:8-4 and the Every Student Succeeds Act (ESSA); and

Whereas, pursuant to N.J.A.C. 6A:8-4.1(d)3iii, the Department shall implement an approved English language proficiency assessment to measure the progress in English language proficiency of MLs with an IEP who have been determined eligible by the individualized education program (IEP) team for an alternative Department-approved English language proficiency assessment for students with disabilities; and

Whereas, pursuant to Section 1111(b)(2) of the ESSA, each state may provide for alternate assessments aligned with the challenging state academic standards and alternate academic achievement standards for students with the most significant cognitive disabilities; and

Whereas, pursuant to N.J.A.C. 6A:8-4.1(d)3, at specific times prescribed by the Commissioner, district boards of education shall administer the alternative assessment for

students with disabilities to students with severe disabilities who cannot participate in other assessments due to the severity of their disabilities; and

Whereas, the WIDA Alternate ACCESS assessment is provided for assessing student progress toward demonstrating a thorough understanding of essential knowledge and skills delineated by the State standards as the alternative English language proficiency assessment for students with severe disabilities; and

Whereas, standard-setting studies were completed in accordance with industry best practices in large-scale assessment to determine the assessments' validity and the theoretically appropriate performance level cut scores; and

Whereas, the State Board acknowledges the Department's selection of the consortium-adopted WIDA Alternate ACCESS performance level cut scores; and

Whereas, the Department will monitor the impact of the test and performance level cut scores on the performance rates for each grade level where the test is administered and will report any problems with the same to the State Board; now therefore be it

Resolved, that the New Jersey State Board of Education hereby approves the following performance level cut scores, effective November 6, 2024:
