Malikah C. Morris serves as the Deputy Director of the Burlington County Department of Human Services.

In this role, she oversees Community Outreach, Community Development, Food Security, and Housing Services, directing systems and initiatives that support more than 450,000 residents. Ms. Morris has led several transformative efforts in Burlington County, including the establishment of the Burlington County Housing Hub, serving as a principal contributor to the development of the County's first emergency shelter, and implementing inaugural housing, health, and utility resource fairs that have collectively supported thousands of residents. She has also directed major food access initiatives, including the County's emergency food distribution partnership that served over 48,000 residents during the pandemic and earned Burlington County recognition as the first government recipient of the Feeding South Jersey Champion Award. In 2025, she strengthened long-term food access infrastructure by piloting the Burlington County Food Hub.
