



**Minutes of the Government Records Council
December 9, 2025 Public Meeting – Open Session**

I. Public Session:

- **Call to Order**

The meeting was called to order at 1:40 p.m. by Mr. John Alexy via Microsoft Teams.

- **Pledge of Allegiance**

All stood and recited the pledge of allegiance in salute to the American flag.

- **Meeting Notice**

Mr. Alexy read the following Open Public Meetings Act statement:

“This meeting was called pursuant to the provisions of the Open Public Meeting Act. Notices of this meeting were faxed to the Newark Star Ledger, Trenton Times, Courier-Post (Cherry Hill), and the Secretary of State on December 4, 2025.

II. Executive Director’s Report:

Official Welcome to New Staff Attorneys

The GRC also welcomes two (2) staff attorneys: Brenda Alves and Rosevalda Julceus. Ms. Alves joins the GRC from the New Jersey Department of Transportation and Ms. Julceus joins from private practice. Both have had a quick start to their training cycle. We look forward to integrating both Ms. Alves and Ms. Julceus into the adjudication process shortly.

Current Statistics

- Since OPRA's inception in July 2002, the GRC has received 7,600 Denial of Access Complaints. That averages about 323 annual complaints per 23 ½ tracked program years. So far in the current program year (FY2026), the GRC has received 216 Denial of Access Complaints.
- 580 of the 7,600 complaints remain open and active (7.6%). Of those open cases:
 - 7 complaints are on appeal with the Appellate Division (1.2%);
 - 23 complaints are currently in mediation (4.0%);
 - 1 complaint is proposed for the Office of Administrative Law (0.2%);
 - 10 complaints await adjudication by the Office of Administrative Law (1.7%);
 - 43 complaints are tentatively scheduled for adjudication at an upcoming GRC meeting, which includes the current meeting (7.4%);
 - 496 complaints are work in progress (85.5%); and
 - 0 complaints are being held in abeyance (0.0%).

The GRC notes that the 216 Denial of Access Complaints received since July 1, 2025 amounts to about 2 complaints per workday over that time frame. The GRC has already received and opened 19 Denial of Access Complaints in December 2025 and has not yet reviewed for intake upwards of 20 complaints received since December 5, 2025 alone. The GRC notes that these counts do not include numerous attempted complaint filings created through AI services and absent the required forms or attachments.

- Since Program Year 2004, the GRC has received and responded to 41,786 total inquiries, averaging about 1,857 annual inquiries per 22 ½ tracked program years (the GRC did not track inquiries in the agency's first year). So far in the current program year (FY2026), the GRC has received 760 inquiries (7.0 inquiries per workday).

GRC Outreaches

- The GRC's 17th Annual OPRA Seminar will be held virtually on Thursday, December 11, 2025. Joining the GRC again this year will be the Office of Information Privacy and Records Management Services. Credit status has been obtained through Local Government Services and the Continuing Legal Education Board. For the first time in the history of this seminar, the GRC reached capacity at 1,000 attendees by the beginning of last week.

III. 2026 Proposed Council Meeting Dates – Final Review

- Mr. Caruso read the proposed meeting dates for 2026. Mr. Alexy called for a motion to approve the meeting dates. Mr. Chen made a motion, seconded by Ms. Berg Tabakin, to approve the 2026 meeting dates. The motion passed by a unanimous vote.

 - The Custodian did not unlawfully deny access to the subject OPRA request because she disclosed all records that existed. N.J.S.A. 47:1A-6; Danis v. Garfield Bd. of Educ. (Bergen), GRC Complaint No. 2009-156, *et seq.* (Interim Order dated April 28, 2010).
 - Mr. Alexy called for any discussion on the Executive Director's findings and recommendations as written. Hearing none, Mr. Alexy called for a motion to accept the Executive Director's findings and recommendations as written. Mr. Chen made a motion and Ms. Berg Tabakin seconded the motion. The motion passed by a unanimous vote.

2. **Thomas and Nancy Ferrante v. Borough of Paramus (Bergen) (2023-128)**

- A portion of Complainants' request item No. 1 and all of request item No. 2 are invalid because they failed to identify specific records. MAG Entm't, LLC v. Div. of ABC, 375 N.J. Super. 534, 546 (App. Div. 2005); Bent v. Stafford Police Dep't, 381 N.J. Super. 30, 37 (App. Div. 2005); Lagerkvist v. Office of the Governor, 443 N.J. Super. 230, 236-237 (App. Div. 2015).
- The Custodian unlawfully denied access to the remaining portion of Complainants' OPRA request item No. 1 and shall either locate and disclose to Complainants' responsive records, provide a specific lawful basis for denial, or certify if no records exist.
- Mr. Alexy called for any discussion on the Executive Director's findings and recommendations as written. Hearing none, Mr. Alexy called for a motion to accept the Executive Director's findings and recommendations as written. Mr. Chen made a motion and Ms. Berg Tabakin seconded the motion. The motion passed by a unanimous vote.

3. **Veronica Gasmen v. Township of Lacey (Ocean) (2024-4)**

- The Custodian lawfully denied access to the requested draft meeting minutes under the "inter-agency or intra-agency advisory, consultative, or deliberative material" exemption. N.J.S.A. 47:1A-1.1; N.J.S.A. 47:1A-6.
- Mr. Alexy called for any discussion on the Executive Director's findings and recommendations as written. Hearing none, Mr. Alexy called for a motion to accept the Executive Director's findings and recommendations as written. Mr. Chen made a motion and Ms. Berg Tabakin seconded the motion. The motion passed by a unanimous vote.

4. **Elizabeth Stochak v. Alexandria Township Board of Education (Hunterdon) (2024-35)**

- The Custodian unlawfully denied access to the responsive meeting recording. N.J.S.A. 47:1A-6; Burlett v. Monmouth Cnty. Bd. of Chosen Freeholders, GRC Complaint No. 2009-49 (February 2010). However, the GRC declines to order disclosure because same occurred on February 7, 2024, and again on March 9, 2024.
- There is no knowing and willful violation.
- Mr. Alexy called for any discussion on the Executive Director's findings and recommendations as written. Hearing none, Mr. Alexy called for a motion to accept the Executive Director's findings and recommendations as written. Mr. Chen made a motion and Ms. Berg Tabakin seconded the motion. The motion passed by a unanimous vote.

5. **Everett Falt v. Borough of Carteret (Middlesex) (2025-196)**

- The Custodian's failure to submit a Statement of Information resulted in a violation of N.J.A.C. 5:105-2.4.
- The Custodian's response was insufficient because she failed to address each OPRA request item individually. N.J.S.A. 47:1A-5(g); Paff v. Willingboro Bd. of Educ. (Burlington), GRC Complaint No. 2007-272 (May 2008).

- The Custodian may have unlawfully denied access to the portion of the Complainant's OPRA request seeking individual e-mails. N.J.S.A. 47:1A-6. Thus, the Custodian shall either locate and disclose to the Complainant responsive records, provide a specific lawful basis for denial, or certify if no records exist.
- Mr. Alexy called for any discussion on the Executive Director's findings and recommendations as written. Hearing none, Mr. Alexy called for a motion to accept the Executive Director's findings and recommendations as written. Mr. Chen made a motion and Ms. Berg Tabakin seconded the motion. The motion passed by a unanimous vote.

VIII. Court Decisions of GRC Complaints on Appeal: None

IX. Complaints Adjudicated in NJ Superior Court & NJ Supreme Court:

- Vele v. Borough of Englewood Cliffs, 2025 N.J. Super. Unpub. LEXIS 1935 (App. Div. 2025): In 2021, defendants denied several requests for the Mayor's e-mails potentially contained in multiple personal/non-government business accounts. The trial court held that disclosure was required, and after a lengthy, convoluted process supervised by the court, it issued financial sanctions when the Mayor failed to comply. The Appellate Division upheld some financial sanctions and remanded to the trial court for further action. Reversed and remanded for further proceedings.

XI. Public Comment:

- Gary Marek, Esq.: Mr. Marek stated that he tried signing up for the OPRA webinar and received an error message. Mr. Caruso advised that the annual seminar, which was capped at 1,000 attendees, was full and that the GRC hoped to post the recording to its website following the event. Mr. Caruso also noted that the GRC will have to consider whether to increase the attendance cap for next year's seminar.
- Mr. Keith Bendel: Mr. Bendel wished everyone happy holidays and wanted to know if mediation decisions were available on the website. Mr. Caruso advised that Administrative Dispositions where complaints were "Settled in Mediation" are accessible through the "GRC Decision Search" website page. Mr. Bendel clarifying that he was asking whether the actual outcomes of the mediations, including communications were available for review. Mr. Caruso stated that pursuant to the Uniform Mediation Act and GRC regulations, mediation communications are confidential and not available for public review.

XII. Adjournment:

Mr. Alexy called for a motion to end the Council meeting. Mr. Chen made a motion, which was seconded by Ms. Berg Tabakin. The motion passed by a unanimous vote. The meeting adjourned at 2:12 p.m.
