- Discussed pre-hospital needle chest decompression errors

OEMS Report – Ms. Gardner

 OEMS will be looking to post and hire into multiple different positions ranging from regulatory officer, nursing consultants, paramedics etc.

Conference, Awards Ceremony, and SIM

- Save the Dates, November 19th through 23rd
- Speakers have been selected. The selections were made based on last year's feedback to change things up. Sessions will focus on interactive and cutting-edge presentations.
- Over 360 proposals for 100 spots all-time record
- Nominations for the 2024 EMS Awards Program is open through August 20, 2024.
- 8 Teams registered

Data

- OEMS is working on data quality issues
- NEMSIS 3.5 additional fields
 - edisposition.32 is causing a lot of confusion at the crew level. Level of Care provided per protocol:
 - Many are not reporting at all which affects the overall aggregate reporting of ALS vs BLS
 - Multiple incidences where BLS documents and reports ALS procedures
 - Some agencies are still sending 3.4 data check your forms/check with your vendor

Opioid

- Naloxone leave behind agencies can get free naloxone through DHS
- Opioid bags with treatment/recovery are being distributed to County EMS Coordinators quarterly
- The Department is working to implement a pilot program MATTERS project

NREMT met, in person with all Paramedic Programs

- There will no longer be a psychomotor examination
- New Advanced life support examination will be launched on 7/1/2024 sample questions can be viewed at www.nremt.org
- Announced more individuals certified than ever before
 - No shortage Distribution of providers is the issue
- NJ has the #1 pass rate Nationally (EMT & Paramedic)

Issues with Reciprocity

- Online educational programs are being taken without any clinical or field hours, competencies, or required portfolio
- This issue was discussed at length during state officials meeting Eastern Region and NASEMSO are looking to develop/share standards

Regulations

- No update for OEMS regulations but the Department is confident the industry will be happy with the proposed changes
- Recommendations for language in 8:43G were suggested to enhance the education and care provided to pediatric patients
- When all regulatory changes/updates have been published and adopted they will set the landscape for the future, streamline the process for protocols, new skills and scope
- Scope of practice advancement for BLS under construction for Albuterol, CPAP, PEEP, and glucometry
 - Glucagon is not being included in the advancement
 - Glucagon is not in the national scope of practice for BLS
 - The depth and breadth of education at the different provider levels is part of the challenge
 - Data and evidence are necessary to prove the need
- Whole blood waiver for all mobile intensive care programs is forthcoming. The
 Department will be rescinding the current aeromedical waiver and implementing a new
 waiver for all

Projects

- Researching mechanisms to obtain funding to create a Public Awareness campaign for EMS and utilization of 911
- OEMS is working with State Psychiatric Facilities to develop awareness, education, and standardized approach for on site medical care, transfer, and utilization of 911 system.
 - Policies for use to form a consistent approach
 - Pilot hope to later utilize with other local facilities (Extended care facilities/nursing homes)

Stakeholder Engagement Meetings

 OEMS has completed stakeholder meetings and collaborative workgroups with our interdepartmental partners for Mobile Integrated Health. In process of scheduling meetings and workgroups with external stakeholders

Issues

- OEMS has received reports of potential systemic issues regarding patient contact, coercion/intimidation of BLS to recall ALS
- OEMS charged the MICU Advisory Council with the responsibility of coming up with a universal definition and policy to be utilized as an industry best practice when defining what constitutes a patient contact

EMSC & Special Projects

- Prehospital Pediatric Readiness Project Assessment
 - The New Jersey EMSC program completed this assessment as a pilot state, in collaboration with North Carolina and the Mariana Islands. As part of a nationwide initiative, the focus is on evaluating the preparedness of Emergency Medical Services (EMS) agencies in handling pediatric patients. NJ EMSC assisted in setting the groundwork for the remaining states and territories which was launched in May 2024.
 - NJ's EMSC team and all NJ EMS agencies a 100% response rate for the agencies who met the assessment criteria. NJ continues to set the bar high for others across the nation and they should be applauded
- Always Ready for Children EMS is a free program that highlights the readiness of EMS
 agencies to care for critically ill and injured children. If your EMS agency is interested in
 participating in this free program call or send an email to emsc@doh.nj.gov
- Free Monthly Education in addition to electronic announcements, classes and registration information will now also be on the EMSC landing page on the EMS website

OEMS Education – Mr. Kazar

- New NREMT ALS certification exam begins on July 1, 2024
- Agencies A-L renewals are due in December
- Regional representatives within OEMS have been established. These individuals will allow for your agency to have a direct contact within OEMS to handle new vehicles, reportable events and to address any inquiry as it relates to agency licensure.
- OEMS Investigators have noticed an increase in unsecured vehicles. It is crucial to ensure that all vehicles are securely locked to mitigate any potential risks
- As a reminder, unless you have been approved to utilize the BLS Non-Emergent Staffing Waiver, ALL licensed BLS ambulances are to be staffed with two (2) EMTs
- OEMS will be holding an instructor meeting on June 13, 2024, for all instructor levels
- OEMS continues to notice Instructors not entering students into their class rosters.
 Please be reminded that this is a regulatory requirement and offenders will be held accountable
- Paramedic Inactive requests will be completed by the end of June. If the Paramedic that
 is going inactive wants to obtain their EMT certification for one (1) year, they may apply
 at the same time they apply for inactive status. All Paramedic Inactive requests are to be
 completed online in the providers NJEMS account
- Background check process is being finalized. All providers will need fingerprints upon initial rollout
- Paramedic Students can start RSI beginning with the first day of field internship so long as the Medical Director, Clinical Educator, Preceptor and Student agree and the student has met minimal competency
- Since January 1, 2024, OEMS has approved 1,656 CEU classes which does not included classes that were reviewed and/or denied
- Since January 1, 2024, OEMS has approved 1,039 Refreshers classes which does not included classes that were reviewed and/or denied
- The Department is not issuing extensions for the June 30, 2024, certification cycle
