New Jersey WIC Program records indicate that your store has <u>not</u> attended the required Annual Vendor Training, FFY 2024.

NJ WIC has scheduled additional Interactive Trainings for Vendors who have missed previous sessions. Failure to join the scheduled webinar will prevent your store from participating as a WIC Vendor for the October 1, 2024 – September 30, 2027 authorization period.

A minimum of one store representative must join the webinar. It is suggested that the store representative you select is someone who will be responsible for the daily supervision of cashiers and WIC transactions.

The NJ WIC Annual Vendor Training will be hosted on **GoToWebinar** and will require registration to ensure your store location(s) receives credit for attendance Upon completion of the mandatory online interactive training session, a Vendor Agreement will be provided for the store representative to sign. The signed Vendor Agreement must be submitted by email to <u>NJ.WICVendor@doh.nj.gov</u> prior to <u>September 11, 2024</u>.

Chain stores are eligible to submit <u>ONE</u> signed Vendor Agreement for all their NJ WIC authorized store locations. The submission of the Vendor Agreement must also include a list of all applicable stores included under this Agreement.

NJ WIC Annual Vendor Training sessions will be conducted on the following dates and times. Please select <u>ONE</u> and register <u>BEFORE</u> the session.
