Note: Exceptions to the Vendor Selection Criteria may be granted if the State agency determines that a vendor is needed for participant's access or in the event of a disaster situation, in accordance with the State agency's policies.

\*Specialty Stores inclusive of Kosher and Halal stores may:

- Replace Kosher milk for cow's milk.
- Kosher stores may be exempt from maintaining Baby Food Meats in stock.

A statement of Rabbinical Supervision must be on file in your NJ WIC record.

\*<u>Minimum Stock Requirements for Baby Foods</u>: One 2-pack counts as 2-4oz. individual containers.

Example: (16) 4oz. Baby Fruit = (8) 2-4oz. individual containers

(32) 4oz. Baby Vegetable = (16) 2-4oz. individual containers
