As you were advised by telephone today, the Department has determined to lift the curtailment of admissions imposed on the facility, effective immediately, conditioned upon the facility's compliance with its revised written plan for an infection control outbreak, which the facility submitted to the Department on March 11, 2019. As required by the January 29, 2019 Revised Notice of Lifting of Directed Plan of Correction (DPOC) and of Conditions for Lifting Curtailment, the facility's written plan addressed how it will communicate collaboratively with the Department's Communicable Disease Service, how it will communicate with the resident and/or resident representative, and how it will address the need for cohorting of residents.

Please be reminded that, in addition to complying with its written plan, the facility is required to comply with all applicable regulations, including but not limited to N.J.A.C. 8:39-13.4(b), which requires infection control training for all staff at least twice a year, rather than only annually.

Please be advised that failure to comply with any State regulations and/or with the conditions for lifting of this curtailment order will result in the imposition of further enforcement remedies, including but not limited to, civil monetary penalties, and may include summary suspension and/or license revocation.
