On October 15, 2021 the Department of Health (Department) issued a Curtailment of Admissions Order, requiring the facility to remain closed to all admissions, and to submit a Directed Plan of Correction, requiring the facility to, inter alia, hire additional staff to meet the requirements of N.J.S.A. 30:13-18 and N.J.A.C. 8:39-5.1(a), in addition to retaining an outside staffing agency to ensure the facility met staffing requirements. The Department memorialized this directive in a written order dated October 15, 2021.


On Survey's recommendation the Department hereby lifts the October 15, 2021 Curtailment of Admissions and Directed Plan of Correction Order, which was based on a September 28, 2021 survey.

New Vista must continue to comply with the April 13, 2020 Emergency Conditional Curtailment of Admissions Order, which is directed to all New Jersey Nursing Homes and Assisted Living Facilities setting forth the minimum requirements to effectively cohort its residents. New Vista shall also continue to comply with the applicable standards in N.J.A.C. 8:39-1 et seq. (Standards for Licensure of Long Term Care Facilities) as modified by the operational waivers, the unwaived Medicare conditions of 42 C.F.R. 483.1 et seq. (Requirements for Long Term Care Facilities), the conditions as modified by the Centers for Medicare & Medicaid services 1135 blanket waivers, and the New Jersey specific 1135 waivers.
