Dear Mr. Hussain:

This letter will confirm the March 7, 2023 conversation with you and staff from the Department of Health, Office of Program Compliance ("the Department"). The Department informed you that, effective immediately, Diagnostic Imaging Center, LLC d/b/a AQ Imaging (NJ25013)(Facility) shall cease and desist from providing all radiology services, including computed tomography (CT) and magnetic resonance imaging (MRI) scans because the Facility's license expired on July 31, 2021.

The Facility admitted to operating under an expired license. On February 21, 2023 Mr. Parmar, who is listed as the Facility's Administrator, advised Department staff that the license for the above facility expired effective as of July 31, 2021, and that the Facility continued operations. Therefore, pursuant to N.J.A.C. 8:43E-3.11 Diagnostic Imaging Center, LLC d/b/a AQ Imaging (NJ25013) is barred from providing any radiology services.

Be advised that in accordance with N.J.A.C. 8:43E-3.4(a)1, that Diagnostic Imaging Center, LLC d/b/a AQ Imaging is subject to fines of \$1,000.00 per day for operation of the Facility in violation of this order, as well as possible further enforcement action pursuant to law and regulation.


