The Health Care Facilities Planning Act (N.J.S.A. 26:2H-1 et seq.) (the Act) provides a statutory scheme designed to ensure that all health care facilities are of the highest quality. Pursuant to the Act and N.J.A.C. 8:43E-1.1 et seq. (General Licensure Procedures and Standards Applicable to All Licensed Facilities), the Commissioner of Health is authorized to inspect all health care facilities and to enforce the Manual of Standards for Licensing of Ambulatory Care facilities set forth at N.J.A.C. 8:43A-1.1 et seq.

Pursuant to N.J.S.A. 26:2H-12, no health care service or health care facility may operate unless it has a license.

**ORDER LIFTING CEASE AND DESIST ORDER**

As you were notified verbally on June 3, 2024, effective beginning June 3, 2024, the Department ordered ODI Diagnostic Imaging of Newark, LLC to cease and desist providing services. The written order was issued on June 3, 2024. This enforcement action was taken because ODI Diagnostic Imaging of Newark, LLC's license expired on April 30, 2024. Because the facility was licensed on July 25, 2024, the Department notified the facility verbally on February 5, 2025, that the Department has lifted the Cease and Desist Order effective July 25, 2024. This formal order confirms that the Cease and Desist Order was lifted on July 25, 2024.
