On October 22, 2021, the Department of Health (Department) issued a written Curtailment of Readmissions and Services Order and Directed Plan of Correction (DPOC). The DPOC required the facility to retain the full-time services of a Licensed Nursing Home Administrator, Director of Nursing, Infection Control Preventionist Consultant (ICPC), clinical evaluations of all residents by a Physician or Advanced Practice Nurse, Licensed Pest Control Provider, Laundry Service, Cleaning Service, Consultant to perform a global facility assessment, and Management Company.


On February 1, 2022, the Department lifted the October 15, 2021 Curtailment of New Admissions Order. On December 29, 2021 the Department lifted the October 22, 2021

Curtailment of Readmissions Order. By verbal Order and this written Order, the Department lifts the October 22, 2021 Curtailment of Readmissions and DPOC.

The Facility must continue to comply with the applicable standards in N.J.A.C. 8:39-1 et seq. (Standards for Licensure of Long Term Care Facilities) as modified by the operational waivers, the unwaived Medicare conditions of 42 C.F.R. 483.1 et seq. (Requirements for Long Term Care Facilities), the conditions as modified by the Centers for Medicare & Medicaid services 1135 blanket waivers, and the New Jersey specific 1135 waivers.
