ORDER LIFTING DPOC
REQUIREMENTS TO RETAIN
ADMINISTRATOR AND REGISTERED
NURSE CONSULTANTS

On January 14, 2022, the Department of Health (Department) issued a Directed Plan of Correction which, among other things, required Woodland Behavioral and Nursing Center (Woodland) to retain an Administrator Consultant to work on site at least 40 hours per week. On January 21, 2022, the Department issued an Amended Directed Plan of Correction which, among other things, required Woodland to hire a Registered Nurse Consultant to work on site at least 40 hours per week. On May 27, 2022, the Superior Court of New Jersey, upon application by the Department and the Department of Human Services, issued an order appointing Allen Wilen of EisnerAmper as the temporary receiver for Alliance HC 11 LLC (owner of Woodland) and appointed Atlantic Health System, Inc. (Atlantic Health) as the manager of Woodland pending the return date of the Order to Show Cause concerning the Department’s application for appointment of a receiver. As a result of this order and the transition in management of the day-to-day operations of the facility to Atlantic Health and Woodland’s new administrator, Keith Grady, retained by Atlantic Health, and the appointment by Atlantic Health of a new Director of Nursing, Deborah Granata, the Department finds that it is no longer necessary for Woodland to continue to retain the Administrator and Registered Nurse Consultants, and, therefore, the Department hereby lifts the Directed Plan of Correction and Amended Directed Plan of Correction to the extent that they require retention of these consultants.
