CEASE AND DESIST ORDER

The Health Care Facilities Planning Act $(N.J.S.A. 26:2H-1 \ \underline{et} \ \underline{seq}.)$ (the Act) provides a statutory scheme designed to ensure that all health care facilities are of the highest quality. Pursuant to the Act and $N.J.A.C. 8:43E-1.1 \ \underline{et} \ \underline{seq}.$ (General Licensure Procedures and Standards Applicable to All Licensed Facilities), the Commissioner of Health is authorized to inspect all health care facilities and to enforce the Manual of Standards for Licensing of Ambulatory Care facilities set forth at $N.J.A.C. 8:43A-1.1 \ \underline{et} \ \underline{seq}.$

Pursuant to N.J.S.A. 26:2H-12, no health care service or health care facility may operate unless it has a license. One Adult Day Care Center Corp's application for accreditation has yet to be approved. Therefore, the facility is not currently accredited by an accrediting body which is a condition for the issuance of a license. In accordance with the provisions set forth at N.J.A.C. 8:43E-3.11, this enforcement action was taken because of evidence suggesting services were being provided at the facility as well as advertisements promoting health care services on the facility website, despite the facility's application for accreditation having yet to be approved, and issuance of a license from the Department.

CEASE AND DESIST ORDER

As you were notified verbally on March 14, 2025, effective March 14, 2025, the Department ordered One Adult Day Care Center Corp to cease and desist providing all services and advertisements, and in the future, to never advertise services it is not licensed to provide.

Please be advised that $\underline{N.J.A.C.}$ 8:43-3.4(a)(1) provides for a penalty of \$1,000 per day for operation of a health care facility without a license.

This Cease-and-Desist Order shall remain in place until the facility is otherwise notified in writing by a representative of the Department.
