As more fully detailed below, the New Jersey Department of Health (the Department) hereby orders One Adult Day Care Center Corp (One Adult) to submit to the Department information that is needed to verify the current operating status of the facility.

On March 14, 2025, the Department ordered One Adult to cease and desist providing all services and advertisements, and in the future, to never advertise services it is not licensed to perform after the Department received evidence suggesting services were being provided at the Facility and found advertisements promoting health care services on the Facility's website, although the Department had not issued a license.

On May 5, 2025, surveyors observed participants being driven in mini and transportation vans to and from The Service Life Church, located at 213 Virginia Ave, New Milford, NJ 07646, by the same drivers who the surveyors had observed at the Facility at 136 Mehrof Avenue in Little Ferry on March 14, 2025. A male, who had identified himself as a volunteer on March 14, 2025 at the Facility, was again a volunteer on May 5, 2025 at the church, and was wearing scrubs and gloves. Two seniors were observed having their blood pressure taken at the church by women wearing scrubs and gloves. One of these women was a nurse who had been at the Facility located at 136 Mehrof Avenue in Little Ferry during the March 14, 2025 survey. The surveyors questioned the staff as to why blood pressures were being measured during a church event. The staff did not provide an answer to this question. Additionally, the staff denied providing that medical service to the police until the surveyor informed them that it was on video. Further, ID badges worn by individuals at the church were the same as those worn by staff at the Facility.

The Health Care Facilities Planning Act (N.J.S.A. 26:2H-1 et seq.) (the Act) provides a statutory scheme designed to ensure that all health care facilities are of the highest quality. Pursuant to the Act and N.J.A.C. 8:43E-1.1 et seq. (General Licensure Procedures and Standards Applicable to All Licensed Facilities), the Commissioner of Health is authorized to inspect all health care facilities and to enforce Standards for Licensure of Adult Day Health Services Facilities set forth at N.J.A.C. 8:43F.

Pursuant to N.J.S.A. 26:2H-5e, "[a]t the request of the commissioner, health care facilities shall furnish to the Department of Health and Senior Services such reports and information as it may require to effectuate the provisions and purposes of this act, excluding confidential communications from patients."

INFORMATION REQUIREMENT ORDER

By July 3, 2025, One Adult Day Care Center Corp shall provide to the Department the following:

- a. Payment source and contact information for each individual who was at the Facility in Little Ferry, NJ on March 14, 2025;
- b. Payment source and contact information for each individual who was at The Service Life Church in New Milford, NJ on May 5, 2025.

N.J.A.C. 8:43E-3.4(a)11 provides a \$250 penalty for the failure to report information to the Department as required by statute or licensing regulation, after reasonable notice and an opportunity to cure the violation, which may be assessed for each day noncompliance is found.
