The Health Care Facilities Planning Act (N.J.S.A. 26:2H-1 et seq.) (the Act) provides a statutory scheme designed to ensure that all health care facilities are of the highest quality. Pursuant to the Act and N.J.A.C. 8:43E-1.1 et seq. (General Licensure Procedures and Standards Applicable to All Licensed Facilities), the Commissioner of Health is authorized to inspect all health care facilities and to enforce the Manual of Standards for Licensure of Pediatric Medical Day Care facilities set forth at N.J.A.C. 8:43J-1.1 et seq.

On July 21, 2022, the Department of Health issued an order curtailing pediatric medical day care services. This action was taken based upon a recommendation from Health Facility, Survey and Field Operations staff as a result of an on-site survey on July 21, 2022, in which deficient practices were identified. The deficient practices included, among other things, failure to have an alternate administrator, failure to have a Director of Nursing, failure to have a social worker and failure to have a Child Life Safety Specialist.

Based upon a recommendation from survey staff, the Department hereby lifts the curtailment of services effective immediately.


