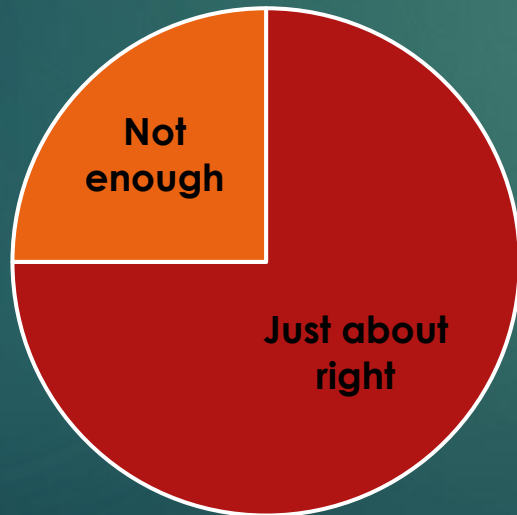

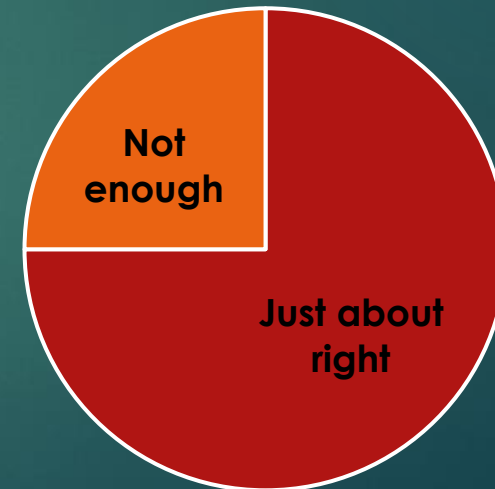
Survey Results

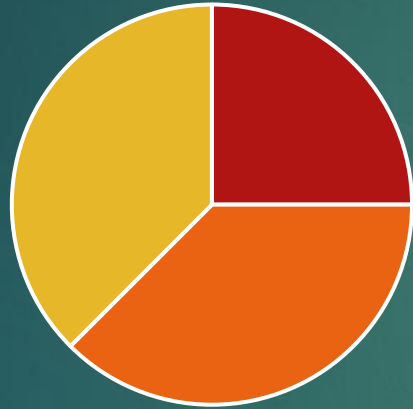
Amount of time you feel you are committing to HNJ2030



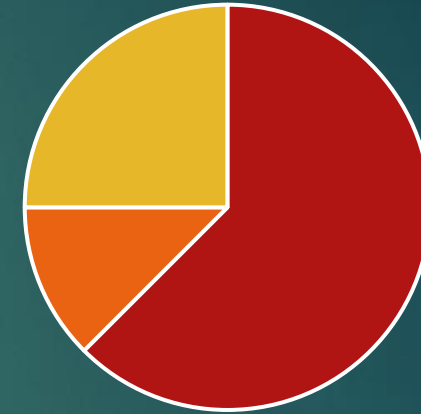

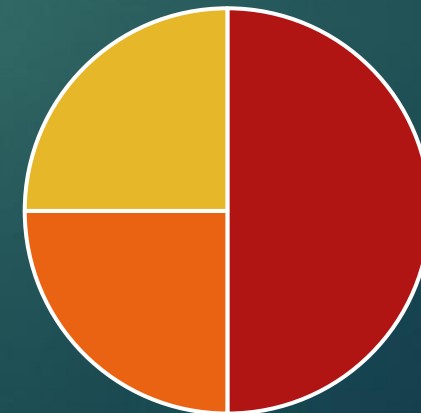
I understand the purpose of the Community Conversations: NJ's COVID-19 Storytelling Project in relation to HNJ2030






My ACT has been kept informed about overall HNJ2030 development



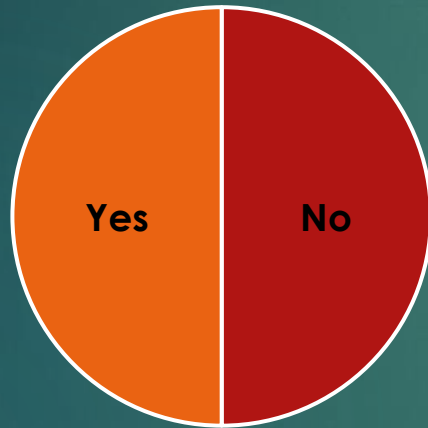

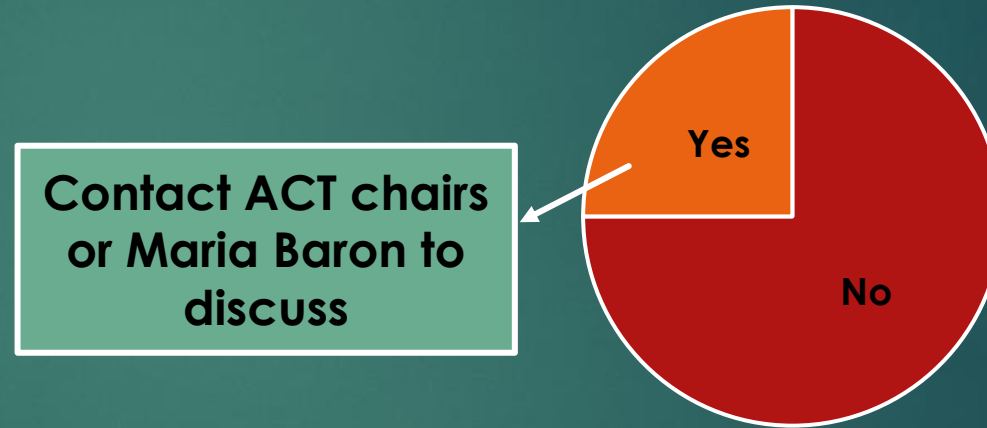
