GENERAL DESCRIPTION

The Research Scientist 3 will report to a Research Scientist 1 and is a member of the Centralized Hub Team responsible for formalizing an information cycle designed to produce integrative insights across health related programs within and outside DOH and develop strategic models for public health policy and decision making.

This position will be tasked with implementing analytical techniques, including generation of statistical models using SAS or other large data manipulation software, employed to integrate evaluation of diverse information pools for creation of data sets used for comprehensive public health policy generation, public services enhancement and response. This includes using raw and filtered information to provide predictive analytics to include risk factors and social determinants of health; applying consistent pressure testing of data quality, workflows and identification of case studies/variants for outcome and activity focused results. Will prepare detailed narrative and/or statistical reports reflecting findings or conclusions from performed analyses.

REQUIREMENTS (EDUCATION / EXPERIENCE / LICENSES)

EDUCATION: Graduation from an accredited college or university with a Master's degree in a discipline appropriate to the position.

EXPERIENCE: Two (2) years of experience in a field appropriate to the position.

NOTE: A Doctorate in a discipline appropriate to the position may be substituted for two (2) years of experience indicated above.

LICENSE: Appointees will be required to possess a driver's license valid in New Jersey only if the operation of a vehicle, rather than employee mobility, is necessary to perform the essential duties of the position.
