GENERAL DESCRIPTION			
<p>Under direction of the Communicable Disease Service (CDS), responsible for designing and conducting routine and specialized scientific investigations and surveillance on sporadic and outbreaks of communicable diseases including COVID-19. Research includes epidemiologic, demographic, healthcare and local public health. Additionally, collecting and analyzing data on disease susceptibility, transmission, severity, risk factors, and outcomes. Research spans existing reportable communicable diseases as well as novel and emerging pathogens such as COVID-19. Scientific research and investigation findings will expand the knowledge of communicable diseases identification, spread, control and prevention and can be used to create new guidelines and recommendations that influence public health policy making in New Jersey.</p>
