<b>GENERAL DESCRIPTION</b>			
<p><b>Conducts Vaccines for Children (VFC), Assessment, Feedback, Incentive and Exchange (AFIX) and mandatory unannounced site visits throughout the State of New Jersey to evaluate vaccine management, ensure compliance with VFC requirements, assess immunization practices and makes necessary recommendations for improvement. Completes all necessary follow-up material, both in written and in computer application form, in order to have an accurate and complete site visit packet. Must be fluent in computers and use of Microsoft and its applications. Performs necessary follow-up with providers to ensure that identified corrective actions are remediated and re-vaccinations performed if necessary. Is a resource to providers in meeting VFC Program requirements and offers timely education in corrective actions. Becomes versed in NJVFC computer applications (NJIS, CoCASA, PEAR and spreadsheets) and is able to obtain necessary information to conduct duties as set forth above. Is accurate and timely in entering all required data. Conduct investigations into allegations of fraud and abuse, under the direction of the Supervising Public Health Representative. Must be able to lift/carry up to 30 pounds and possess a vehicle for transportation.</b></p>

<p><b>EDUCATION:</b> Graduation from an accredited college or university with a Bachelor's degree.</p> <p><b>EXPERIENCE:</b> Two (2) years of experience in a communicable disease related health or social service program which shall have included responsibilities for interviewing, investigating, and/or conducting public health care surveys, or patient care services.</p> <p><b>NOTE:</b> Applicants who do not possess the required education may substitute additional services as indicated on a year-for-year basis with thirty (30) semester hours credits being equal to one (1) year of experience.</p> <p><b>NOTE:</b> A Master's degree in Biological Science, Public Health, Public Health Nursing, Social Services, and/or other related subjects may be substituted for one (1) year of experience.</p> <p><b>LICENSE:</b> Appointee will be required to possess a driver's license valid in New Jersey only if the operation of a vehicle, rather than employee mobility, is necessary to perform the essential duties of the position.</p>
