GENERAL DESCRIPTION			
<p>Under the direction of the Director of the Office of Opioid Response and Policy (ORP), the Public Health Representative Trainee receives training in the planning, implementation, and evaluation of harm reduction program expansion in New Jersey. With Supervisor approval, will attend relevant workshops, conferences, meetings, trainings, seminars, and other professional development offerings as appropriate. Works with municipal and county stakeholders and community members to coordinate harm reduction planning and evaluation. Will learn to organize and conduct public health surveys, focus groups, and other data; compile data obtained; and participates in developing evaluations. Supports the identification of community need for harm reduction and community risks related to overdose and substance use. Prepares correspondence, reports, and presentations for a variety of audiences. Supports the Director in conducting policy analysis and identifying best practices from other jurisdictions. Supports and participates in ORP and overall Departmental programs and initiatives as well as providing support to the other units and offices within the Department of Health, as needed.</p> <p>ADVANCEMENT: Appointees who successfully complete the 12-month training period will be eligible for promotion to the title among the following for which they have been trained: Public Health Representative 3, Public Health Representative 3 Communicable Disease, Public Health Representative 3 Certified Tumor Registrar.</p> <p>This position may be eligible to participate in the Department's pilot telework program, which offers eligible employees the opportunity to work remotely for up to two (2) days per week, as approved by management.</p>
