This interim division is currently established and is expected to remain operational until December 30, 2025.

GENERAL DESCRIPTION

Under the direction of the Communicable Disease Service (CDS), serve as senior Epidemiologist, who will be responsible for designing and overseeing surveillance and epidemiological research and other scientific investigation projects to identify ways to improve prevention and control of COVID-19. Research findings will expand the scientific knowledge of COVID-19 prevention, transmission, and control, and be used to guide New Jersey pandemic response recommendations. This position will lead a team of Research Scientists, Health Data Specialists, and other technical staff, and reviews, modifies, approves, or disapproves studies proposed to ensure compliance with appropriate research and surveillance methodology and statistical techniques. Serves as Primary Investigator (PI) for research studies and coordinates Institutional Review Board (IRB) submissions when needed. Manages high level technical projects and reports results to designated officials for inter- and intra-agency response. Oversee and guide staff on the identification of research metrics and methods to track the incidence and prevalence of COVID-19 in various settings throughout the state including healthcare facilities, long-term care facilities, schools, and other settings. Work includes the development and implementation of innovative response and control measures, based on limited scientific information, and applying ground-breaking research and information gathering techniques to various COVID-19 related transmission events.

REQUIREMENTS (EDUCATION / EXPERIENCE / LICENSES)

EDUCATION: Graduation from an accredited college or university with a Master's degree in a discipline appropriate to the position.

EXPERIENCE: Four (4) years of full-time experience in a field appropriate to the position.

NOTE: A Doctorate in a discipline appropriate to the position may be substituted for two (2) years of experience indicated above.

LICENSE: Appointee will be required to possess a driver's license valid in New Jersey only if the operation of a vehicle, rather than employee mobility, is necessary to perform the essential duties of the position.
