GENERAL DESCRIPTION

Under the limited supervision of a manager or other supervisory official this position will serve as local HIT point person providing grant required technical support for the unit, as well as creating and managing databases for use by both administrative and fiscal branches for tracking and monitoring of the CARES/ELC Award. Helps analyze statistical, financial, and operating reports to assure optimal processes are in place and collaborates with staff to implement best practices and/or process improvements when necessary. Sets and/or reviews workflows to work toward elimination of unnecessary and/or wasteful administrative practices/positions and determine where program and/or administrative duplication may exist. Will Plan, conduct, and develop analytical operations/routines to determine feasibility for data processing and makes recommendations to the unit. Recommends enhancements or new systems, application software, or services to improve production or workflow and to meet current and projected needs. Participates in the planning, development, implementation, and/or maintenance of new or enhanced systems to support the unit and liaisons with CDC on all technical issues related to the award.

REQUIREMENTS (EDUCATION / EXPERIENCE / LICENSES)

EDUCATION: Graduation from an accredited college or university with a Bachelor's degree.

EXPERIENCE: Two (2) years of experience involving the review, analysis, and evaluation of budget, organization, administrative practices, operational methods, management operations, or data processing applications, or any combination thereof, which shall have included responsibility for recommendation, planning, and/or implementation of improvements in a business or government agency.

NOTE: Applicants who do not possess the required education may substitute additional experience as indicated on a year-for-year basis with thirty (30) semester hour credits being equal to one (1) year of experience.

NOTE: A Master's degree in Public Administration, Business Administration, Economics, Finance, or Accounting may be substituted for one (1) year of indicated experience.

LICENSE: Appointees will be required to possess a driver's license valid in New Jersey only if the operation of a vehicle, rather than employee mobility, is necessary to perform essential duties of the position.
